- b) Demonstrate experience in handling, transporting and disposing of scrap metal in an environmentally responsible manner.
- c) Provide valid documentation including business registration, scrap metal dealer license and Tax Compliance Certificate etc.

- a) Application letter.
- b) Company profile and contact information.
- c) Copy of Certificate of Incorporation or Registration Certificate, PIN Certificate, Tax Compliance Certificate.
- d) Current Business license or another applicable license/permit.
- e) Proof of compliance with environmental and waste disposal regulations.
